WHEREAS, the Board of Commissioners is in receipt of Resolution No. 172-25 to Vacate a Portion of Tote Road adopted by the Board of Trustees of Austinburg Township which serves as a petition to the Board of Ashtabula County Commissioners for the proposed vacation of a portion of Tote Road, described as:

Tote Rd. (TH 121 B) 60 foot wide. Beginning at the intersection of the centerline of Tote Road. (TH 121 B) with the northerly bank of the Grand River, north to the intersection of the centerline of Tote Rd. (TH 121 B) with the southerly right of way line of Lampson Road (TH 194 B-C), about 190 feet; and

WHEREAS, In accordance with Section 5553.045 of the Ohio Revised Code, the Board of Commissioners shall review the petition and set the time of a public hearing in said matter; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the petition of the Austinburg Township Board of Trustees for the vacation of a portion of Tote Road in Austinburg Township is hereby accepted for filing.

BE IT FURTHER RESOLVED, said Board hereby sets the date and time of the view as February 4, 2026 at 1:30 p.m. and hereby set February 5, 2026, at 2:30 p.m. as the time and date of public hearing on said vacation in the Conference Room of the Board of County Commissioners, 2nd Floor, Old Courthouse Building, 25 West Jefferson Street, Jefferson, Ohio.
