

RESOLUTION APPROVING THE VACATION OF A PORTION OF TOTE ROAD IN AUSTINBURG TOWNSHIP BY AUSTINBURG TOWNSHIP TRUSTEE PETITION

WHEREAS, a petition was filed by the Austinburg Township Board of Trustees to vacate a portion of Tote Road in Austinburg Township, described as follows:

Tote Rd. (TH 121 B) 60 foot wide. Beginning at the intersection of the centerline of Tote Road. (TH 121 B) with the northerly bank of the Grand River, north to the intersection of the centerline of Tote Rd. (TH 121 B) with the southerly right of way line of Lampson Road (TH 194 B-C), about 290 feet.

BE IT FURTHER RESOLVED, That the Clerk of the Board shall forward a certified copy of this resolution to the Austinburg Township Trustees, the Ashtabula County Recorder and the Ashtabula County Engineer.

BE IT FURTHER RESOLVED, once the certified copies of the resolution declaring Tote Road vacated are filed, the Austinburg Township Board of Trustees, by resolution, shall order Tote Road vacated.
