WHEREAS, Terry Moio, Sheriff's Department, has prepared a grant application to the Ohio Department of Public Safety for use by the Ashtabula County Sheriff's Office; and

WHEREAS, the program for this grant is designed to create deterrence and change unlawful traffic behaviors where law enforcement efforts are combined with visibility and publicity strategies to educate the public and promote compliance with the law; and

WHEREAS, the administering agency must first incur the cost for approved expenditures and then apply for the reimbursement with appropriate and accurate documentation for each expense, as this federal grant program operates on a reimbursement basis.; and

WHEREAS, the federal grant period has a 12-month cycle from October 1, 2026 thru September 30, 2027 in the amount of \$49,451.76 (IDEP is \$23,975.88 and STEP \$25,475.88); and

WHEREAS, The Commissioners feel submitting this grant application is desirable and necessary; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio that the grant application be made to the Ohio Department of Public Safety for use by the Ashtabula County Sheriff's Office in accordance with the terms outlined in the grant, with a copy of said application on file in this office.
