

RESOLUTION ORDERING REQUEST FOR BIDS FOR THE PROPOSED DISPOSAL OF CERTAIN WATER DISTRIBUTION FACILITIES WITHIN THE COUNTY GENERAL WATER & SEWER DISTRICT (GREEN ROAD), ACDES

WHEREAS, it is now necessary to order a Request for Bids for the sale of 1,872 LF, 8-inch transit waterline with along Green Road (formerly known as Infirmary Road) in Kingsville Township; and

WHEREAS, this bid is being ordered pursuant to Ohio Revised Code Section 6103.31 and requires that any interested bidder be a purveyor regulated under the Public Utilities Commission of Ohio under Title 49 of the Ohio Revised Code; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that a bid opening will be held on the 26th of August, 2021 at 2:30 p.m. at the office of the Ashtabula County Commissioners and the Clerk of the Board is hereby ordered to advertise in a newspaper of general circulation, via the internet at the Ashtabula County Website, "<http://ashtabulacounty.us/bids>" and to post notice of said request for bids on the bulletin board as required by law.
