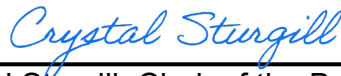

The purpose of this letter is to confirm Ashtabula County Board of Commissioners (Ashtabula County) has permitted The Ohio State University Extension office in Ashtabula County (OSUE) to locate and utilize office space at 39 Wall Street, Jefferson, Ohio 44047.

Ashtabula County will provide office and program space to OSUE beginning July 1, 2026 through June 30, 2027. This space includes: the eastern office spaces, including the annex, and the basement (excluding the storage space used by Ashtabula County).

As a condition of its usage, OSUE agrees it shall not make any structural changes to the building or spaces without the authorization of the Ashtabula County. OSUE agrees to exercise reasonable care in the use of any audiovisual equipment provided by Ashtabula County and comply with all applicable federal, state, and local laws, regulations and requirements in their storage and use.

There is no fee for the use of this space. Cleaning of these office spaces is shared by the Parties. Ashtabula County will provide electric, heat/air, water, and general maintenance. Phone and internet services are paid by OSUE.

Each party agrees to be responsible for the liabilities arising out of their own conduct and the conduct of their officers, employees and agents.

The OSUE contact person will be Kim Howard, for all issues related to facilities and equipment. Her contact information is howard.577@osu.edu and phone 440-576-9008. OSUE and Ashtabula County acknowledge that any amendments to the terms outlined in this letter shall occur in writing and only be valid upon the signature of authorized agents for OSUE and Ashtabula County. OSUE and Ashtabula County will review this document annually.

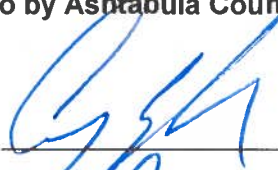
