

RESOLUTION HOLDING SECOND PUBLIC HEARING ON ASHTABULA COUNTY'S PY 2026 APPLICATION TO OHIO DEPARTMENT OF DEVELOPMENT OFFICE OF COMMUNITY ENHANCEMENT FOR COMMUNITY HOUSING IMPACT AND PRESERVATION (CHIP) PROGRAM GRANT, PLANNING AND DEVELOPMENT

WHEREAS, This being the date and time set for the second public hearing on the Ashtabula County's Community Housing Impact & Preservation Program application for PY2026; and

WHEREAS, Ashtabula County Department of Planning and Development personnel will explain the eligibility requirements, filing requirements, grant period, proposed activities, proposed budget and outcomes of the PY 2026 Community Housing Impact & Preservation Program application; and

WHEREAS, the following was presented:

Ashtabula County along with the Cities of Ashtabula, Conneaut and Geneva are applying for the Community Housing Impact & Preservation Program funds as a partnership with Ashtabula County acting as the lead agency. As lead agency Ashtabula County intends to submit an application to the Ohio Department of Development's Office of Community Enhancement for the PY 2026 CHIP grant in the amount of \$1,350,000.00. The application is being prepared by the Department of Planning and Development.

The County will be presenting an application for the partnered Community Housing Impact and Preservation Program application in the amount of **\$1,350,000.00** (Ashtabula County \$400,000.00; Ashtabula City \$350,000.00; Conneaut City \$300,000; Geneva City \$300,000) to the Ohio Department of Development Office of Community Enhancement the following projects:

- Rehabilitation Assistance - Owner Rehabilitation- \$797,000.00 (HOME & CDBG) – 10 Outcomes;
- Repair Assistance – Owner Home Repair- \$405,000.00 (CDBG & OHTF) – 19 Outcomes;
- Fair Housing- \$12,000.00 (CDBG); and
- General Administration - \$136,000.00 (CDBG & HOME).

Below is a breakdown of each Community's budget and outcomes

Ashtabula County

- Rehabilitation Assistance – Owner Rehabilitation- \$236,000.00 (HOME & CDBG) – 4 Outcomes;
- Repair Assistance – Owner Home Repair- \$120,000.00 (CDBG & OHTF) – 4 Outcomes;
- Fair Housing- \$5,000.00 (CDBG); and
- Administration - \$39,000.00 (CDBG & HOME).

Ashtabula City

- Rehabilitation Assistance - Owner Rehabilitation – \$207,000.00 (HOME & CDBG) – 3 Outcomes
- Repair Assistance – Owner Home Repair – \$105,000.00 (CDBG & OHTF) – 4 Outcomes
- Fair Housing – \$3,000.00 (CDBG); and
- Administration - \$35,000.00 (CDBG & HOME)

Conneaut City

- Rehabilitation Assistance - Owner Rehabilitation – \$177,000.00 (HOME & CDBG) – 2 Outcomes
- Repair Assistance – Owner Home Repair – \$90,000.00 (CDBG & OHTF) – 3 Outcomes
- Fair Housing – \$2,000.00 (CDBG); and
- Administration - \$31,000.00 (CDBG & HOME)

Geneva City

- Rehabilitation Assistance - Owner Rehabilitation – \$177,000.00 (HOME & CDBG) – 3 Outcomes
- Home Repair – \$90,000.00 (CDBG & OHTF) – 3 Outcomes
- Fair Housing – \$2,000.00 (CDBG); and
- Administration - \$26,000.00 (CDBG & HOME)

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the public hearing held on the proposed grant application to the Ohio Department of Development Office of Community Enhancement for the PY 2026 Community Housing Impact and Preservation Program funds is hereby adjourned.
