

RESOLUTION AMENDING RESOLUTION 2026-287 APPOINTING JESSICA BRUNDAGE TO THE ASHTABULA COUNTY DISTRICT LIBRARY BOARD

WHEREAS, pursuant to Section 3375.22 of the Ohio Revised Code, the Board of County Commissioners created the Ashtabula County District Library Board for the control and management of the Ashtabula County District Library in accordance with Ohio Revised Code Sections 3375.33 through 3375.41; and

WHEREAS, the initial terms of the members of the Ashtabula County District Library Board appointed prior to September 30, 2025, were established as seven (7) year terms; and

WHEREAS, pursuant to Ohio Revised Code Section 3375.22, trustees appointed to a new term on or after September 30, 2025, for a county district library board established before that date shall serve four (4) year terms; and

WHEREAS, Ohio Attorney General Opinion No. 2026-OPN-0007 confirmed that appointments to new terms on such boards are to be for four (4) years; and

WHEREAS, Resolution No. 2026-287, adopted on June 23, 2026, appointed Jessica Brundage to the Ashtabula County District Library Board for a seven (7) year term ending May 18, 2033; and

WHEREAS, Resolution No. 2026-287 should be amended to reflect the statutorily required four (4) year term ending May 18, 2030; now

THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Ashtabula County, Ohio, that Resolution No. 2026-287 is hereby amended to provide that Jessica Brundage's appointment to the Ashtabula County District Library Board shall expire on May 18, 2030, rather than May 18, 2033.

BE IT FURTHER RESOLVED, that all other provisions of Resolution No. 2026-287 shall remain unchanged and in full force and effect.
