

RESOLUTION AUTHORIZING INCREASE IN ANNUAL CREDIT CARD USAGE LIMITS FOR THE ASHTABULA COUNTY DOG WARDENS AND THE ASHTABULA COUNTY NURSING & REHABILITATION CENTER, IN ACCORDANCE WITH THE ASHTABULA COUNTY CREDIT CARD USAGE POLICY, SECTION 8.10 OF THE ASHTABULA COUNTY PERSONNEL MANUAL

WHEREAS, in accordance with Ohio Revised Code Section 301.27, on August 2, 2016 by Resolution 2016-204 the Ashtabula County Board of Commissioners established a Credit Card Usage policy; and

WHEREAS, said policy being amended on August 30, 2017 by Resolution No. 2017-246; and

WHEREAS, on February 2, 2021 by Resolution No. 2021-12FINA, authorization was granted to county departments for the use of county credit cards with limits established and users approved; and

WHEREAS, the following offices have requested an increase in their credit card limit, as outlined below:

Ashtabula County Dog Wardens from \$10,000 to \$20,000

Due to operational expenses

Ashtabula County Nursing & Rehabilitation Center from \$20,000 to \$80,000

Due to a vendor who has substantial fees if paying by check

WHEREAS, this Board of Commissioners feels such increases are necessary and would agree to the increases outlined above; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the annual credit card limit for the Ashtabula County Dog Wardens and the Ashtabula County Nursing & Rehabilitation Center are hereby increased as outlined above.
