In accordance with Ohio Revised Code Section 307.381 and 3781.20, the Board of Commissioners shall appoint members to serve on the Ashtabula County Board of Building Appeals, with the terms of the members set at five (5) years; and

WHEREAS, Thomas Lueders has submitted his resignation from the Ashtabula County Board of Building Appeals; and

WHEREAS, the Board has considered the resignation request and accepts such resignation effective February 4, 2021; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that resignation of Thomas Leuders from the Ashtabula County Board of Building Appeals is hereby accepted effective February 4, 2021.


Dear Mr. Leuders,
