WHEREAS, on the 10th day of December, 2019 by Resolution Number 2019-19ACNH the Board of Commissioners provided authorization to engage and retain the services of Mansour Gavin, LPA in order to advise Ashtabula County in the Tracey Caylor Et Al V. Ashtabula County DBA Ashtabula County Nursing and Rehabilitation Center lawsuit for an amount not to exceed \$10,000; and

WHEREAS, the Ashtabula County Board of Commissioners comes today to increase said amount by another \$10,000, not to exceed \$20,000 in total for this representation, due to the request of the attorneys to pursue settlement of the case while they wait for a court ruling; and

WHEREAS, this Board of Commissioners would agree to the request of an additional \$10,000 for a total cost not to exceed \$20,000, for this case; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, the Ashtabula County Board of Commissioners agree to the increase as outlined above. The cost of same shall be borne by the Ashtabula County Board of Commissioners.
