III. PROJECT DESCRIPTION

Ashtabula County will use its PY 2019 Critical Infrastructure Program funding to assist the City of Conneaut with comprehensive repairs to the infrastructure along Chestnut Street. The project will replace 900 linear feet each of 24" storm sewer line, 12" water line, and 8" sanitary sewer line. The roadway surface will also be replaced with a 3" asphalt course and full depth pavement repair where required. The project will alleviate severe flooding, inflow and infiltration, and eliminate damage caused by repeated work to repair each isolated incident. The project will benefit 10,975 individuals, 55 percent of whom are LMI per the American Community Survey. This project includes \$100,000 from Ashtabula County's PY 2019 Allocation Program. 8/18/21: Extension #1 - 60-day extension to 12/31/21 due to COVID supply chain disruptions and water main break; also extending B-F-19-1AD-1 grant.
