

**RESOLUTION ACCEPTING THE TREASURER'S ESTIMATE OF RESOURCES FOR ACTIVE DEPOSITORYES AND SETTING TIME AND DATE TO ACCEPT PROPOSALS FOR REQUEST FOR BANKING SERVICES AND APPLICATIONS/AGREEMENTS FROM BANKING INSTITUTIONS**

WHEREAS, The Ashtabula County Treasurer has presented an estimate of resources which may be available for active depositories of Ashtabula County for the acceptance of the Board of Commissioners; and

WHEREAS, pursuant to Section 135.33 of the Ohio Revised Code the Treasurer has estimated that \$1,000,000.00 to \$90,000,000.00 of public monies of Ashtabula County may be available for active depositories during the succeeding four (4) year period from December 1, 2021 through November 30, 2025; and

WHEREAS, it is necessary to notify eligible institutions that the Board of County Commissioners will be accepting proposals for banking services and applications/agreements for the designation of Public Depositories for Active Funds of Ashtabula County to be received in the office of the Board until 2:00 p.m. on Monday, September 27, 2021 at which time institutions submitting proposals for banking services and applications/agreements will be noted for the record and forwarded to the Treasurer for review and recommendation; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, the Treasurer's Estimate of Resources is hereby accepted and the notice setting the time and date to accept proposals for banking services and applications/agreements is hereby ordered to be sent to eligible banking institutions relative to the application/agreement for the designation of public depositories for active funds.
