

This Amendment to the Health Related Transportation Contract #21-3004-HRT (the "Contract") is made and entered into effective as of August 1, 2021, between the Ashtabula County Job and Family Services and The Ashtabula County Commissioners or its governing body (collectively, "Grantor") and City Cab & Transfer Co., Inc. ("Subgrantee").

Grantor and Subgrantee agree to the following:

1. Paragraph 4 of the Contract shall be modified to read in its entirety:

- 4. Availability of Funds:** Payments for services provided in accordance with provisions of this Contract are contingent upon availability of Transportation funds allocated for this service. The total amount of reimbursement available under this Contract will not exceed:

PURCHASE OF TRANSPORTATION SERVICE CONTRACT FOR HUMAN SERVICE PROGRAMS-HEALTH RELATED TRANSPORTATION : \$350,000.00 and shall not exceed the actual cost of service.

5. To the extent that any of the terms and conditions of this Amendment are inconsistent with the terms and conditions of the Contract, the terms and conditions of this Amendment shall prevail.
6. Each reference to the Contract that is made in the Contract or any document ancillary thereto shall be construed as a reference to the Contract, as amended by this Amendment.




