1. To increase the wage scale based on the Clemans and Nelson proposed wage scale for the Dietary, Housekeeping and Laundry department effective September 3, 2021. The new starting wage for the above classifications is \$11.25 per hour. Any employee in the above departments earning less than \$11.25 per hour shall now earn the minimum of \$11.25 per hour.
