WHEREAS, a public hearing was held on June 15, 2021 and the Board determined that it was in the best interests of the County to dispose of the certain water distribution facilities within the County General Water & Sewer District (Green Road) pursuant to Resolution 2021-25SEWA adopted on July 8, 2021; and

WHEREAS, in accordance with ORC 6103.31, Water Supply Facilities Sale or Disposition, the Board of Commissioners ordered bids on July 27, 2021 by Resolution Number 2021-31SEWA for the proposed disposal of certain water distribution facilities within the County General Water & Sewer District (Green Road); and

WHEREAS, bids were received and opened on August 26, 2021, as follows:

Aqua Ohio, Inc.	\$1.00

WHEREAS, the bid of Mr. Sankey was incomplete, as it did not include bid form attachments A to D or any of the data required in the Request for Bids to demonstrate the bidder's capabilities, experience, and qualifications to maintain and service the waterline and customer base; and

WHEREAS, it has been recommended to accept the bid of Aqua Ohio, Inc. as the bid was complete and Aqua Ohio, Inc. is experienced and qualified to satisfactorily maintain the waterline and service the customer base; and

WHEREAS, this Board of Commissioners would concur with the recommendation and award the bid to Aqua Ohio, Inc. as the most responsible bidder determined to be in the best interests of the county and users of the facility for the sum of \$1.00; now

THEREFORE, BE IT RESOLVED by the Board of Commissioners of Ashtabula County, Ohio, that the bid be awarded to Aqua Ohio, Inc. for certain water distribution facilities within the County General Water & Sewer District located on Green Road in Kingsville Township, Ohio.
