WHEREAS, this Board concurs with the recommendation and revisions; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the revised Prevention, Retention and Contingency (PRC) Program be approved effective retroactive to October 1, 2021, in accordance with a copy of said plan, now on file in this office.


