

RESOLUTION APPROVING THE RE-PLAT OF ASHTABULA MALL RESUBDIVISION NUMBER 10 – A REPLAT OF LOT 4 RESIDUE OF ASHTABULA MALL RESUBDIVISION NUMBER 8 OF THE ASHTABULA MALL PLAT IN ASHTABULA TOWNSHIP

WHEREAS, the Ashtabula Mall Subdivision was filed on March 5, 1992; and

WHEREAS, Sublot 4 (Permanent Parcel Number 03-052-00-004-00) was re-platted on May 20, 1993 to create sublots 4-1 and 4-2; and

WHEREAS, Sublot 4 was re-platted on October 1, 1996 and Sublot 4-3 was created; and

WHEREAS, the proposed replat of Sublot 4 residue does not entail the extension or establishment of additional right-of-way or public infrastructure; and

WHEREAS, Jake Brand, Director of the Ashtabula County Department of Community Services and Planning has submitted the following as the essential and basic elements of this proposed Plat application summarized as follows:

- Parcel 03-052-00-004-00 will be split into 2 parcels. Parcel 4-4 will be a 2.203-acre parcel and Parcel 4-5 will be a .704 acre parcel.

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the re-platting of Ashtabula Mall Resubdivision Number 10 – a replat of Lot 4 residue of Ashtabula Mall Resubdivision Number 8 of the Ashtabula Mall Plat in Ashtabula Township is approved, as outlined above.
