

RESOLUTION RE-APPOINTING JOSEPH RAPOSE TO THE ASHTABULA COUNTY SENIOR SERVICES LEVY ADVISORY BOARD AND REDUCING MEMBERSHIP

WHEREAS, The Board of Commissioners created the Ashtabula County Senior Services Levy Advisory Board to assist and advise the Ashtabula County Department of Job and Family Services and this Board in the development and coordination of programs and available services for Ashtabula County's seniors; and

WHEREAS, The initial terms on the Ashtabula County Senior Services Levy Advisory Board are 3 years and were staggered to allow for an orderly progression of re-appointments so that the services of the Board are not disrupted; and

WHEREAS, Michelle Thomas and Rhonda Rodriguez have not expressed an interest to be reappointed to the board upon the end of their terms December 31, 2021; and

WHEREAS, Joseph Rapose has expressed an interest to be re-appointed to a new term beginning January 1, 2022 and ending December 31, 2024; and

WHEREAS, It has been recommended to not seek additional board members at this time to replace Michelle Thomas and Rhonda Rodriguez and to change the size of the board to 13 members verses 15 members; and

WHEREAS, The Board of Commissioners concur with the recommendations and hereby accept the resignations of Michelle Thompson and Rhonda Rodriguez upon the fulfillment of their terms through December 31, 2021; the re-appointment Joseph Rapose with a term beginning January 1, 2022 and ending December 31, 2024 and to reduce the membership of the board to 13 members; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the re-appointment, resignations and membership reduction of the Ashtabula County Senior Services Levy Advisory Board, as outlined above, are hereby approved.
