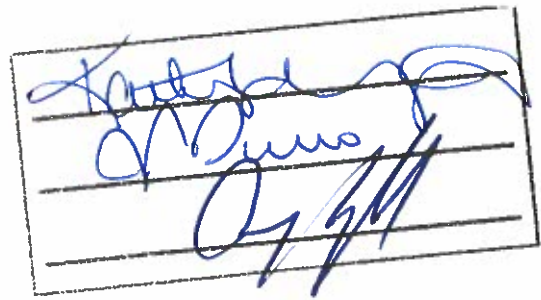

Pursuant to Section 321.261, of the Ohio Revised Code, this office hereby submits the 2021 Delinquent Tax and Collection (DTAC) report.

The 2021 appropriation for the Treasurer's Office was \$254,402.00. The DTAC Land Bank appropriation was \$145,000.00. Expenditures through today, November 9, 2021 are as follows:

Remaining expenditures through 12/31/2021 are estimated to be \$32,246.72 for a total of \$262,048.42.

DTAC Treasurer's fund (2042-003-100) receipts are estimated at \$175,000.00 which is \$105,000.00 estimated for the County Treasurer's half pursuant to section 321.261 and \$70,000.0 estimated as Land Bank reimbursement for human resource expenses. Land Bank (2042-003-242-436) 2021 receipts are estimated at \$120,000.00. All amounts listed are projections and are subject to change based on the amount of delinquent taxes collected.
