Grant Period: July 1, 2021 thru June 30, 2023

Amount: increases funding in the amount of \$3,304.00 from the original amount of \$549,960.00, for total funding not to exceed \$553,264.00 for FY 2022/23; and

**ADDENDUM TO
COMMUNITY-BASED CORRECTIONS PROGRAM
407 SUBSIDY GRANT AGREEMENT**

This Addendum is between the State of Ohio, Department of Rehabilitation and Correction, and Ashtabula County. It modifies the fiscal year 2022/23 Community-Based Corrections Program 407 subsidy grant agreement in the amount of \$549,960.00.

The grant award shall be increased by \$3,304.00 to \$553,264.00 effective on the date approved by the Deputy Director of the Division of Parole and Community Services in the Ohio Department of Rehabilitation and Correction. Total expenditures for Fiscal Years 2022/23 (July 1, 2021 to June 30, 2023) will not in any case exceed \$553,264.00.
