

RESOLUTION NOT APPROVING THE PROPOSED VACATION OF A PORTION OF LAKEVIEW DRIVE IN SAYBROOK TOWNSHIP

WHEREAS, in accordance with Ohio Revised Code 5553.042(B), a road vacation petition was filed with the Ashtabula County Board of Commissioners by Joshua Strickland, Dworken & Bernstein Co., L.P.A, Attorney for abutting landowner Philip Moroco for that portion of Lakeview Drive in Saybrook Township between Highland Avenue and Morningside Avenue, that was previously abandoned by the Commissioners in 1990; and

WHEREAS, a public hearing was held on January 12, 2021 by Resolution 2021-41 regarding the matter of the vacation of a portion of Lakeview Drive in Saybrook Townships, described as follows:

DESCRIPTION OF PORTION OF LAKEVIEW DRIVE

Beginning at the intersection of the centerline of Lakeview Dr. and the eastern line of Highland Ave., thence continuing east 190.2 feet to the intersection of the centerline of Lakeview Dr. and the western line of Morningside Ave.

WHEREAS, the County Engineer has submitted his report; and

WHEREAS, acting in good faith and for the public convenience and welfare this Board of Commissioners hereby does not approve the vacation of the portion of Lakeview Drive in Saybrook Township; now

THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Ashtabula County, Ohio, that the portion of Lakeview Drive in Saybrook Township, as described above, is declared not vacated; and

BE IT FURTHER RESOLVED, that the Clerk of the Board shall forward a certified copy of this resolution to the petitioner, the Ashtabula County Engineer, and the Saybrook Township Trustees.


