WHEREAS, the plan has been completed, and

WHEREAS, on Community Services & Planning did transmit the documentation and pertinent information concerning the proposed update to the Comprehensive Plan to the Ashtabula County Planning Commission for a recommendation; and

WHEREAS, a public hearing was held on December 20, 2021 by the Planning Commission on the Comprehensive Plan update, and
