Subject: Rehiring Account Payable Position - Pay Grade 6 Nursing Home

We would like to rehire Connie Farr 60 days after her retirement. Her current rate is \$16.75/hour which is slightly above the minimum based on her pay grade. (Clemens-Nelson study) I am proposing to rehire her at that rate. The subject does not require health insurance.

Connie has been an asset to the nursing home. She has dedicated 32 years of her life to the nursing home. Her knowledge of New World Systems for the county and Point Click Care for the nursing home reporting would be hard to replace. A new employee would most likely require hours of training and constant supervision. It is not easy to be able to understand both processes especially under the current environment.

Connie Farr last day on current employment will be December 22, 2020. The nursing home would like to rehire her on March 2, 2021. In the interim we would have a process to fill her temporary void.
