WHEREAS, Kim Dunford has notified the Board of Commissioners that she intends to retire on June 30, 2022 and be re-employed on July 1, 2022; and

WHEREAS, a public notice shall be posted on the Ashtabula County Website under public Notices not less than 60 days before the re-employment and a public meeting shall be held between fifteen and thirty days before the employment as a re-employed retiree is to begin; and

WHEREAS, said public notice will be placed on the Ashtabula County website on Wednesday, April 20, 2022 which is 60 days before the re-employment; and

WHEREAS, a public meeting on the issue of the re-employment will be held on Tuesday, June 14, 2022 at 1:30 p.m. in the offices of the Ashtabula County Commissioners, 2<sup>nd</sup> Floor, Old Courthouse, 25 W. Jefferson St., Jefferson, Oh 44047; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio, that the public notice will be posted hearing on the County's website and the public meeting will be held on June 14, 2022 at 1:30 p.m. in the Commissioners' Conference Room, 2<sup>nd</sup> Floor of the Old Courthouse Building in Jefferson, Ohio.
