

**RESOLUTION APPROVING THE DETAILED CONSTRUCTION PLANS FOR THE NEW LONDON ROAD WATERLINE PROJECT, GENEVA TOWNSHIP**

WHEREAS, Doug Starkey, Director of the Ashtabula County Department of Environmental Services, has presented detailed construction plans prepared by the Ashtabula County Engineer's Department, for a project involving the extension of the waterline along a section of New London Road in Geneva Township; and

WHEREAS, The project description is as follows; to-wit:

The project is located in Geneva Township. It involves the installation of 2,903 feet of 8" waterline along a section of New London Road. The starting point for this project is in parcel number 17-019-00-013-00 and marked as Station 60+00.2 on the drawings. The end point is in parcel number 17-019-00-019-00 and marked as Station 89+02.6 on the drawings.

WHEREAS, Doug Starkey, Director of ACDES, recommends approval of these plans; now

THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of the County of Ashtabula, Ohio, that:

**Section 1.** The detailed construction plans for the New London Road Waterline Installation Project in Geneva Township, as presented to this Board by the Ashtabula County Engineer are hereby approved.

**Section 2.** Those detailed plans shall be filed in the office of the Ashtabula County Sanitary Engineer, in the Department of Environmental Services and kept continuously on file there for inspection by all persons interested therein.
