

RESOLUTION DECLARING NO BIDS RECEIVED AND AN EMERGENCY FOR THE PURCHASE OF REINFORCED CONCRETE PIPE FOR 2022 CULVERT PROJECTS, ENGINEER'S OFFICE

WHEREAS, Tim Martin, Ashtabula County Engineer, has informed this Board that a real and present emergency exists as bids were ordered and then due on April 27, 2022 at 10:00 a.m., with no bids being received for Reinforced Concrete Pipe for the 2022 Culvert projects; and

WHEREAS, the situation has been reviewed and it is found that the delay of time to re-bid will delay the availability beyond the time construction can occur to utilize the pipe and the pipe is meant to replace aging and failing culverts that are under our roadways and postponing the work will increase the likelihood that the traveling public might encounter a dangerous condition along our highways; and

WHEREAS, informal quotes have been received from three firms, as follows:

Rinker Materials	\$168,589.28
Abd Tarazi, LLC	\$178,021.84
Northern Concrete Pipe	\$ 96,656.38

WHEREAS, Northern Concrete Pipe is a reputable company and the most cost-effective with a cost of \$96,656.38 and their quote is within the estimate of our original bid; and

WHEREAS, all three quotes will be kept on file for a period of at least one year after the purchase is made; now

THEREFORE, BE IT RESOLVED, By the Board of Commissioners of Ashtabula County that pursuant to Ohio Revised Code Section 307.86(A), an emergency is declared for the purchase of reinforced concrete pipe for the 2022 culvert projects.

BE IT FURTHER RESOLVED, the cost will be paid from MVGT funds.
