

RESOLUTION RECEIVING JANSSEN PAYMENT 1 AND 2 AND DISTRIBUTOR PAYMENT 2 FROM THE LOCAL GOVERNMENT SHARE OF THE OPIOID SETTLEMENT, DEPOSITING INTO THE 2004 OPIOID SETTLEMENT FUND AND DESIGNATING \$10,000 OF SAID SETTLEMENT TO THE ANDOVER POLICE DEPARTMENT AND THE BALANCE OF \$948.10 TO CRIME ENFORCEMENT AGENCY OF ASHTABULA COUNTY (CEAAC)

WHEREAS, Ashtabula County is a Local Government that has adopted and approved the OneOhio Memorandum of Understanding which establishes a mechanism to disburse settlement proceeds from the opioid litigation into Ohio's communities to help abate the opioid crisis, and

WHEREAS, pursuant to the terms of the Memorandum, 30% of the settlement proceeds will be paid directly to local governments, including Ashtabula County, for approved purposes as delineated by the Memorandum, and

WHEREAS, Andover Police Department has requested funding assistance for new OVI equipment, as the current BAC Datamaster OVI breath test machine was purchased in 1997 and at the end of the year, operators will no longer be certified by the Ohio Department of Health to use the machine; and

WHEREAS. The Crime Enforcement Agency of Ashtabula County (CEAAC) is a multi-jurisdictional crime task force which investigates narcotics trafficking, helping with drug abatement and other multi-jurisdictional crimes throughout Ashtabula County; and

WHEREAS, The Ashtabula County Board of Commissioners is in receipt of settlement funds from Janssen Payment 1 and 2 (\$2,416.81 and \$5,638.47 which total: \$8,055.28) and Distributor payment 2 in the amount of \$2,892.82, equaling a total amount of \$10,948.10; and

WHEREAS, Ashtabula County Board of Commissioners hereby designates \$10,000.00 of these funds to the Andover Police Department and \$948.10 to Crime Enforcement Agency of Ashtabula County (CEAAC); now

NOW, THEREFORE, BE IT RESOLVED that the Ashtabula County Board of Commissioners hereby designates funds for the total amount of \$10,948.10 received from the local government share of the Opioid Settlement, as outlined above.
